You must request for the recognition of your bachelor diploma at the **Czech University** which provides similar study modules. If you studied in economic field, recognition requirements at the University of Economics, Prague are described in this document. In case you studied in different study modules, the application requirements depend on the University where you will apply for the recognition. Please find these information at their websites; their application requirements will be partial different from the requirements of the University of Economics, Prague.

The process of recognition of your previous university degree **depends on the country** where the diploma was issued. Countries are divided into three groups, please find the country where was your diploma issued and the exact process is described bellow the chart where the country is.
