Prague University of Economics and Business, (Vysoká škola ekonomická v Praze – VŠE) is the leading university in the fields of management and economics in the Czech Republic with about 14,000 students and 600 professors. In March 2024, VŠE became the first university in the Czech Republic to receive accreditation from the Association to Advance Collegiate Schools of Business (AACSB). High priority is given to the development of international relations, and nowadays it has more than 250 partners from Europe, North and South America and Asia.
